



**MINUTES OF MARCH 19, 2019
REGULAR MEETING OF THE SAN GABRIEL CITY COUNCIL**

CALL TO ORDER

Mayor Harrington called the regular meeting of the San Gabriel City Council to order at 6:39 p.m. on Tuesday, March 19, 2019, in the Council Chamber at City Hall, 425 South Mission Drive, San Gabriel, California, 91776.

Vice Mayor Menchaca thanked outgoing Mayor Harrington for a good year and stated she is looking forward to working with Mayor Pu.


